The Undersigned acknowledges that all activities at Mile High Equestrian, including, without limitation, walking, grooming horses, tacking horses and horseback riding (referred to in this document as "Activities") could be hazardous. When participating in any activity involving horses please remember that horses are unpredictable animal that can intentionally or unintentionally kick you, step on you or throw you off. Please use extreme caution when participating in the Activities.

I acknowledge that Mile High Equestrian has Activities that involve great risk of physical injury and possibly death. I recognize there are risks including, without limitation, falls, impacts, man-made and natural objects, other individuals, varying weather conditions, uneven and irregular terrain which create difficult walking and riding conditions. I further understand that I freely and expressly assume and accept all risk of injury, death or damage to my person and property associated with participating in Activities at Mile High Equestrian.

Taking part in any Activities at Mile High Equestrian facility, I agree to defend, indemnify, release and hold harmless Mile High Equestrian and its employees, shareholders, members, directors, officers, contractors, agents, representatives and assigns (the "Released Parties") from any and all liability, claims, demands, actions and causes of action out of or related to any injury to persons or property, including death, property damage, or loss sustained in connection with my Activities at Mile High Equestrian, including those claims based on negligence or breach of warranty by any of the Released Parties. I also agree to defend, indemnify and hold harmless the Released Parties for any and all claims brought by a third party which arise from my participation in any Activities.

Any equipment or animals used by me in connection with Activities at Mile High Equestrian are accepted "AS IS" condition and I accept full responsibility for the care of the

equipment while in my possession. I understand and agree that I am responsible for the full replacement value of any equipment or horse not returned and I agree to pay for any damage to the equipment that exceeds normal wear and tear. I represent and warrant that I, the rider, am in good health and have no problems that hinder my ability to safely participate in Activities. If I am signing this liability release on behalf of a minor (less than 18 years of age) ("the Child") the Child shall be bound by all terms of this release of liability and I represent and warrant that I am the parent and/or legal guardian of such Child and that the Child is in good health and there are no special problems with the care of the Child.

I accept responsibility and agree to indemnify and hold harmless the Released Parties against and from all the Child's medical expenses incurred in connection with the activity. I agree to defend, indemnify and hold harmless the Released Parties against and from any and all claims brought by the Child, and I agree to defend, indemnify and hold harmless the Released Parties for any and all claims brought by a third party arising in connection the Child's participation in the Activities at Mile High Equestrian or through the Released Parties.

I authorize a licensed physician, dentist, and or other medical care provider to carry out any emergency medical care of the Child or myself, and I agree to pay all cost associated with such medical treatment and related transport of the Child or myself.

I understand that an adult must accompany children under the age of 13 at all times. If I am signing this liability release on behalf of a minor (less than 18 years of age) ("the Child") the Child shall be bound by all terms of this release of liability and I represent and warrant that I am the parent and/or legal guardian of such Child and that the Child is in good health and there are no special problems with the care of the Child. I understand that, if I invite or allow my friends, family, or other persons ("Guests" defined as persons not named on this release form) to participate in the Activities I assume, on such Guest's behalf, all risks associated with participating in the Activities at Mile High Equestrian or through the Released Parties. Additionally, I agree to defend, indemnify and hold harmless the Released Parties from and against any claim whatsoever, whether present or future, brought by any of my Guests in connection with the Activities at Mile High Equestrian or through the Released Parties.

This release of liability supersedes any other agreement or representations by or between the parties and is governed by the laws of the State of Colorado and is intended to be interpreted as broadly as possible and shall be binding to the fullest extent of the law. I agree that exclusive jurisdiction and venue for any legal action shall be in the district court of Arapahoe County, Colorado of the federal court of the State of Colorado. If any part of this agreement is determined to be unenforceable, the remaining terms shall be an enforceable contract between the parties. It is the Undersigned's intent that this release of

liability shall be binding upon the assignees, subrogors, distributors, heirs, next of kin, executors and personal representatives of the Undersigned. Under Colorado law, an equine professional is not liable for any injury to or death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Section 13-21-119 Colorado Revised Statutes.

Arena and Barn Property Rules and Regulations Agreement

Mile High Equestrian (MHE) rules and regulations are in place for the safety of all riders, staff, and horses. Mile High Equestrian is a facility for private boarding, riding lessons, equine classes and therapeutic riding lessons by certified instructors only. Mile High Equestrian reserves the right to change or revise these rules at any time.

ATTENTION: Either the adult rider or parent/legal guardian of a minor rider needs to initial each line and sign below. Parent or legal guardian's initials indicate that they have reviewed these rules with their minor rider. Signature of minor rider is also required below.
Any violation of these rules may result in your being asked to leave the premises. Initial violations will result in a verbal warning. The third violation will result in dismissal from the property.
All riders must wear ASTM/SEI certified helmets whenever mounted on horseback. Riders over the age of 18 may waive the right to wear a helmet under the conditions they are fully liable for accident, injury or death occurring while riding.
All students and staff are required to promote respect and kindness toward humans, horses, and property at all times.
If you bring children you are responsible for them at all times and they may not be left unattended. We are not responsible for children on property outside of a scheduled lesson/working student time. We are not a child care provider and do not offer a babysitting service.
All trash must be placed in trash cans and all manure must be placed in manure buckets. Do not mix these items.
Do not feed treats or anything other items to any horse without permission.
Do not remove a horse from its stall unless you are approved to do so.
Riders must follow all safety precautions, respect other boarders and community members by following barn rules or they will be asked to leave immediately.
Riders in lessons are not allowed to carry cell phones with them.
Announce yourself (say "GATE" or "DOOR" loudly) when passing, standing by, and before entering the area.

Clean up after yourself in the bathrooms, lounge, tack rooms, crossties, and
arena areas. Sweep your crossties before and after using them. All tack and equipment
must be put away after riding and not left in aisles or the arena.
The barn is not responsible for the loss, theft, or damage of personal property.
Only dogs belonging to employees or staff are allowed on the property (and these must be supervised at all times). No other dogs or animals are allowed on the property without property owner permission.
No smoking is allowed anywhere on the property (this includes all forms of e-Cigarettes and vapes). MHE is a drug-free property.
During MHE instructed lessons riders must wear long pants and shoes with a hee at least $\frac{1}{2}$ " but no more than 1 $\frac{1}{2}$ " (tall boots, paddock boots, or cowboy boots).
Mile High Equestrian reserves the right to enforce weight restrictions on horses should a rider's weight jeopardize the health or safety of the horse.
